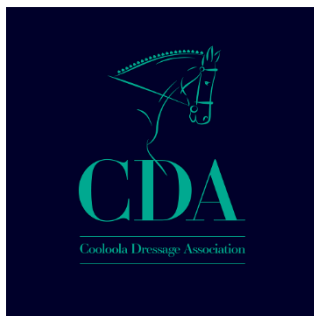

General Conditions of Entry

- A copy of a correctly completed Horse Health Declaration must be handed in on arrival to the competition grounds before riding.
- All Biosecurity procedures must be followed.
- EA Rules Apply
- **Workers (over 18) need a current Blue Card - number must be recorded on the entry form.**
- **No refunds after close of entries unless vet / medical certificate supplied.**
 - In case of cancellation an administration fee of 20% may be retained by the organising committee of the club
 - If less than 4 riders in any class prize money may be halved on discretion of Committee.

Each horse and rider combination may only compete in a total of 3 classes in two consecutive levels on any one day.

Participant Prep A- **ONLY HORSES WHO HAVE NOT WON A PREP CLASS PREVIOUSLY ARE ELIGIBLE FOR THIS CLASS.**

Yards and Camping are to be paid for in FULL upon nominating and will be allocated to those who book.

Limited Yards and Powered Camping available, Hot Showers and toilets will be opened on Saturday.

Jackpot Conditions

Open to any horse/rider combination – EA registered and non-EA registered.

Open to both horses and ponies.

Open to Senior and Junior riders.

Riders must be members of EA or CDA.

Official horses may not compete at a level lower than their official grading level.

Unofficial horses may only win 4 Jackpot class at the same level (eg Novice) before they are then no longer eligible to compete at that level of Jackpot or lower.

Official judges will be used for the competition.

Entries limited to the first 30 nominations received (reserves will be taken in case of scratchings) if Less than 4 nominations CLASS WILL BE CANCELLED and Entry fee money will be returned.

Jackpot Scores are not eligible for CDA Leaderboard.

Camping \$10 per night per site.

Yards \$10 per yard.

1. Acknowledges, agrees and represents that he/she further agrees and warrants that, if at any time, he/she feels anything to be unsafe, he/she will immediately advise the officials of such and refuse to participate further in the EVENT(S).
2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the club/coach, participants, EFA and its state bodies or any subdivision thereof, officials, volunteers, medical personnel, any persons, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the EVENT(S), premises and event inspectors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents and employees, all for the purposes as herein referred to as "Releasees", FROM ALL LIABILITY, TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

Each of the UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE/MEDICAL OPERATIONS OR PROCEDURES OF THE RELEASEES.

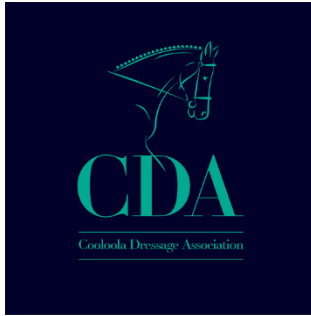
