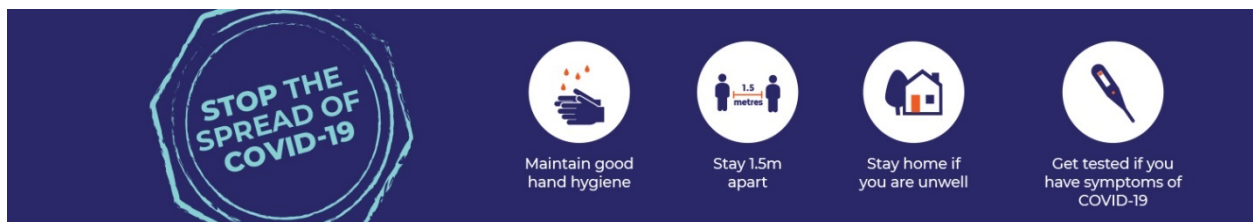

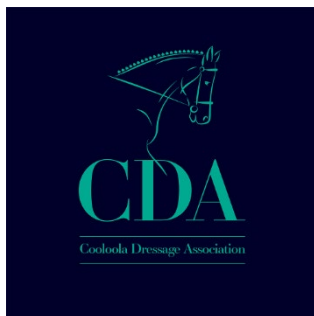

#### **General Conditions of Entry**

- **A copy of a correctly completed Horse Health Declaration must be handed in on arrival to the competition grounds before riding.**
- **ALL attendees MUST check in on Check In Qld app.**
- **All Biosecurity procedures must be followed.**
- EA Rules Apply
- **Workers (over 18) need a current Blue Card - number must be recorded on the entry form.**
- **No refunds after close of entries unless vet / medical certificate supplied.**
- In case of cancellation an administration fee of 20% may be retained by the organising committee of the club
- If less than 4 riders in any class prize money may be halved on discretion of Committee.

Each horse and rider combination may only compete in a total of 3 classes in two consecutive levels on any one day.

**Limited day membership is available- find the addition on nominate to add fee to nominations- Cost is \$20.00**

**Participant Prep A- ONLY HORSE AND RIDER COMBINATIONS WHO HAVE NOT WON A PREP CLASS PREVIOUSLY ARE ELIGIBLE FOR THIS CLASS.**

#### **Jackpot Conditions**

Open to any horse/rider combination – EA registered and non-EA registered.

Open to both horses and ponies.

Open to Senior and Junior riders.

Riders must be members of EA or CDA.

Official horses may not compete at a level lower than their official grading level.

Unofficial horses may only win 4 Jackpot class at the same level (eg Novice ) before they are then no longer eligible to compete at that level of Jackpot or lower.

Official judges will be used for the competition.

Entries limited to the first 64 nominations received (reserves will be taken in case of scratchings) if Less than 4 nominations CLASS MAY BE CANCELLED and Entry fee money will be returned.

Jackpot Scores are not eligible for CDA Leaderboard.

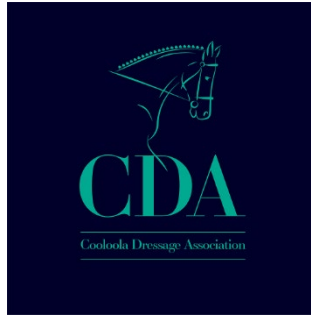
